Dear Sir Keir,

We are writing to ask you to commit to the ambitious action needed to restore the UK's natural environment and to set out your plans ahead of the General Election.

The next Westminster Government has a legal obligation to halt the decline of wildlife in England by 2030. As the Office for Environmental Protection has concluded, the Government is not on track to meet this target, and we have yet to see credible plans from any of the main political parties to stop the ongoing destruction of nature.

Nature's decline is already harming the economy, and failure to halt ecosystem degradation would have serious consequences. The health of our natural world is intrinsically linked to our wellbeing, productivity and economic prosperity. 12% of GDP could be lost as a result of nature-related risks (more than the decline in economic growth caused by the 2008 global financial crisis), communities lack access to nature-rich green and blue space, and we risk losing precious wildlife forever.

By contrast, restoring nature and bringing our natural world back to life would bring huge benefits for the UK. With cross-party support, the Westminster government set the world's first legally-binding target to halt nature's decline by 2030. That was a triumph of ambition and long-term thinking and science-based policymaking. Success would help solve so many of the social and economic issues the UK is grappling with, from a better future for farming, to a more resilient health service.

But unless things change and political parties step up and follow the scientific evidence, the UK will fail to live up to this vital promise. The Office for Environmental Protection says Government must scale up and speed up action or we will not halt nature's decline. The consequences will be felt for generations to come.

Our organisations have a combined membership of more than 8 million people, part of a much wider community of people in the UK and around the world who want a better future for nature. We are writing to the leaders of the UK's larger political parties to ask you to explain how you would meet this historic challenge—and the legally-binding target—if you were elected.

Please don't let the pressures of short-term politics get in the way of simple fact: nature is in a perilously poor state and getting worse, to everyone's detriment. Wildlife has declined by 32% in England since 1970 and 1 in 8 species are at risk of extinction in the UK. We cannot go on like this. How would you turn things around and safeguard our future? The public deserve to know your plans.
